A while ago we started a project to look into the feasibility of an Aquatic Facility, the question that was asked was "Is it feasible?" In the next few weeks the Feasibility Analysis into a potential Aquatic Facility in Break O'Day will be made public providing the community with the opportunity to examine the work which has been completed. It has taken more time than we had hoped but we have also broadened out the report further in the closing stages to look at the socio-economic benefits including a Benefit Cost Ratio analysis as well as a detailed examination of the financial implications of a facility if it is proceeded with. We have always known that Aquatic Facilities run at a financial loss and the options that have been examined are no different, they all run at a loss.

It is critically important that community members take the time to read the report when it has been released and provide your feedback through the survey process. There will be a summary document available but I really encourage people to have a good read of the full version report. There is so much valuable information and insight in this report. Throughout the process we have been assisted by a steering committee which included a number of community members bringing a diverse and important range of perspectives to the considerations and direction of the consultants. I would like to express our great appreciation for the work they have done as well as the consultants, OTIUM who have been incredibly patient and professional through the project.

Scamander River Mouth – Second **Community Survey Now Open**

Thank you to everyone who joined our recent community workshops about coastal and flood hazards at the Scamander River Mouth, Around 20 locals came along to share their ideas, concerns and local knowledge to help plan how we can adapt to future challenges.

The workshops looked at areas that could be affected by flooding or erosion, including Dune Street, Pelican Sands, the northern estuary (lagoon/ backwater), Bridge Esplanade and Upper Scamander Road. Together, participants explored possible actions and solutions for each site.

If you couldn't make it to a workshop, there's still a chance to have your say. A second online questionnaire is now open for feedback. It asks for your thoughts on the proposed actions for each site, when they might need to happen and what would be required to make them work.

Your feedback will help shape practical and affordable solutions for managing future risks and will guide the creation of an overall Adaptation Pathways Plan for the Scamander River Mouth. Visit www.bodc.tas.gov.au/council/current-

We're close to the finalisation of the Feasibility Analysis to develop a new aquatic facility for our community.

It's important that any future decision is based on the very best possibility to enable careful consideration — this will be a generational investment for our municipality, and we want to make sure we get it right.

In the next few weeks, we'll be releasing

a detailed report, FAQ and short explainer video to help everyone in the community understand the nature and implications of the potential project, the options considered, and the work completed so far as well as costs and benefits.

Once this information is available, we'll also be asking for your feedback through a community survey to help guide Council's next steps.

Understanding Land-Clearing Laws — **Protect Our Environment and Community**

Council reminds landowners and residents that clearing vegetation without approval is unlawful under State and local legislation. land-clearing Tasmania's controls protect the natural environment that makes our region special—from forests and coastal scrub to the wildlife that depends on them.

What You Need to Know

Clearing vegetation may require approval under laws such as:

- Land Use Planning and Approvals Act 1993 - planning permits may be required in many zones.
- Forest Practices Act 1985 a Forest Practices Plan is needed for clearing or converting native vegetation.
- Nature Conservation Act 2002 & Threatened Species Protection Act 1995 - protect threatened vegetation and species habitat.
- Even small-scale clearing can require approval. Contact Council's Development Services team before starting any works if unsure.

Why Native Vegetation Matters

Scenic and amenity value: Shapes the character of our towns and landscapes.

- Wildlife habitat: Supports Bennett's wallabies, Tasmanian devils, echidnas, and native birds.
- Water and erosion control: Vegetation prevents erosion. improves water quality, manages floods.
- Climate resilience: Trees and shrubs capture carbon and provide cooling shade.

What You Can Do

- Check first: Seek advice or confirm exemptions via Council or the Forest Practices Authority.
- Retain vegetation: Design property improvements to work with existing plants.
- **Explore LISTmap:** Learn about threatened flora and fauna on your land.
- Seek advice early: Council staff can guide your responsibilities and options.

Weed of the Month - Kunzea ericoides

Kunzea ericoides is a popular hardy and easy-care shrub offered by nurseries that is now an increasingly common invasive weed in the municipality and worldwide.

Common names for it include burgan, white tea-tree, and in its native New Zealand 'kanuka'. It can be hard to identify, looking a lot like local native species prickly or manuka tea-tree (Leptospermum scoparium) and a bit like tick-bush (Kunzea ambigua).

Kunzea ericoides has white tea-tree-like flowers and reddish shoots, tip leaves and fruit capsules. A tough natural coloniser of disturbed ground in New Zealand, here it spreads quickly over bare and disturbed ground, along

roadsides and into bushland. Once established it is hard to control with digging, herbicides, slashing and to out compete with alternative cover. Prevention and hygiene are important.

If you have Kunzea ericoides in your

garden or neighbourhood be vigilant and spread stop seed and any seedlings. Find out about Kunzea ericoides and other invasive weeds at nre.tas. gov.au/invasivespecies/weeds



Protect Our Shorebirds This Nesting Season

As we enjoy the warmer weather, it's also important to remember that shorebird nesting season has now begun across Tasmania. From 1 October, some coastal areas in Break O'Day have dog restrictions in place to help protect these vulnerable birds. Depending on the area, this

may include no dog zones or on-lead requirements. Their eggs are wellcamouflaged in shallow scrapes on the sand and their chicks remain flightless for up to a month before they can fly, so please take care when visiting our beaches. You can help protect these species by walking on the wet sand below the high tide mark, keeping your distance from nesting birds, keeping dogs on a lead and away from nesting areas, avoiding driving on nesting beaches, leaving seaweed and beach debris where they are and disposing of rubbish responsibly. Feralscan App: Report Rabbits, Deer & Cats

Did you know there's an app and website that lets you report feral animals in your area? FeralScan is a national service that collects information on feral species, including deer, rabbits, and cats, which have been affecting our region. This data is shared with government agencies to help

manage populations more effectively. If people want action, it's important to provide evidence on the map e.g sightings, photos and records of losses such as garden or tree damage, vehicle impacts, or near misses. You can report sightings through the FeralScan app or at www.feralscan.org.au
