The clock is quickly ticking down towards the opening of the new Mountain Bike Trails later this year.... something which we are acutely aware of as the various threads we are working on start coming together in a frantic last few months of activity. The interest and engagement of the business community in the project is readily apparent. The most recent Information Session we held on 20 August was attended by approximately 50 people who received an update on the trail project and the elements Council are currently working on including commercial relationships. The business community are recognising the economic benefits which will be coming with the trails and there has been strong interest from businesses towards providing financial support for trail maintenance and development. A Trails Ambassador Program is in the final stages of development by Council officers and will be released shortly which provides a formal structured mechanism for financial support to occur. This is a key element of developing financial sustainability in relation to the MTB Network. It is also important that the experience of riders and visitors extends beyond using the trails themselves which means that related infrastructure and activities are also in place for the opening. There is an opportunity for a small scale commercial business to be established at the Flagstaff Trail Head which is a key part of meeting the needs of riders and visitors. This will occur through a public Expression of Interest process which will be advertised shortly. The St Helens MTB Project is a complicated project, it is far more than just building some trails. It is about ensuring all elements which will make this project an ongoing success for the Break O'Day area come together.

Refurbished Cunningham Jetty OPEN

Two members of the Council works crew, Brett Pallier and Rex Floyed have been working hard on the Cunningham jetty and they have done an amazing job.

The jetty was in a terrible state and had to be closed in December 2017 for safety reasons but check it out now! The new jetty is a bit longer than the previous and also higher so that it won't be affected by high tides anymore.

The new jetty has a bench seat, fish scale table and a Hook, Line and Sinker

collection container. And good news for anglers, one keen fisherman has already caught a few fish from the new jetty! A pot-bellied seahorse has also been spotted hanging around the pylons so keep an eye out for him as well.

Back in December 2017, we were forced to close the Cunningham and Talbot Street jetties as they were deemed unsafe for the public. Then in February 2018, the State Government promised us some funding to refurbish jetties in our area.

larapuna Community Weekend success

More than 120 volunteers and PWS staff spent three days at the start of August walking our larapuna / Bay of Fires coastline scouring over 50km of beaches for marine debris and the beach weed 'sea spurge'.

After years, the six larapuna Community Weekend is helping stop the invasive sea spurge from invading the east coast. 27,000 sea spurge plants were hunted down this year and 11,000 of them removed by volunteers. More than a third of the 338 pieces of marine debris collected with IMAS/ UTas researchers from Adrift Lab were plastic, some were tiny fragments that are deadly for many marine birds and fish.

The larapuna Community Weekend is also about the natural and cultural heritage of this spectacular coastline and bringing people together to share their knowledge, enjoyment and

connection to place.

larapuna Community Weekend is organised by the Parks and Wildlife Service with the Wildcare Friends of larapuna Coast with the support of a host of other partners including Council, the Tasmanian Walking Company, Healthy Tasmania, Aboriginal Land Council of Tasmania, Friends of Eddystone Lighthouse and Adrift Lab at IMAS/UTas.

Beach walkers interested in volunteering to help with a coordinated effort for a sea spurge free East Coast can contact wildcare.larapunacoast@gmail.com and should register with local PWS offices. Care is needed when weeding sea spurge as its white sap is toxic and between spring and autumn disturbance of significant species of birds that nest and raise chicks on the beach affects their breeding success and survival.

Scamander Community Drop-In Session

On Wednesday 7 August we held a Community Drop-In session at the Scamander Sports Complex for Scamander and Beaumaris residents. During the development of our 10 year Strategic Plan we visited 10 townships and promised that we would come back and discuss individual township plans with residents. So far we have visited nine townships and developed seven Township plans, which can be found on our website. These plans are used to help Council understand the focus of the community so we can then prioritise projects and spending in each town.

Approximately 37 people attended the Scamander Drop-in session where a variety of ideas were raised under the headings of Environment, Lifestyle and Other. We also used this opportunity to discuss the Wrinklers Lagoon concept designs with the community. After listening to the community we have amended our plans for the area removing the dump point from the concept design. This draft plan will now go to Council for consideration.

Once all information from the session has been collated it will be released as a draft for consideration and will be emailed to all those that attended and left their email addresses at the session. We will let you know when the draft is ready by promoting it through our Facebook page.

Drought Community Fund to benefit the Fingal Valley

Thanks to a \$1 million Drought Communities grant, Break O'Day Council (BODC) will start working on a variety of projects in the Fingal Valley aimed at activating employment and economic opportunities.

The Fingal Valley, due to its focus on agriculture, has been impacted by the drought with not just farmers but the entire community feeling the economic pinch.

The aim of the Federal Government's Drought Community Funding is to support local community infrastructure projects that focus on stimulating local community spending, use local resources and provide lasting benefit to communities and the agricultural industries on which they depend.

With these guidelines in mind, BODC first started looking at projects that had been raised by the Fingal Community for inspiration. They also advertised an Expression of Interest for employees that could undertake labour style work. Through this process the Council identified several walking tracks in the area that had been flagged as needing work as well as a number of infrastructure projects proposed by the community.

Council is working in partnership with Parks and Wildlife on some of the trail projects which include; Mathinna Falls, Gray Mares Tail Falls and the St Patricks Head track. Once these projects are completed, these striking trails will be more easily accessible for visitors to St Marys Markets the Fingal Valley.

In terms of infrastructure projects, recently developed Local Township Plans were reviewed and projects identified for inclusion were a Bus Shelter at Mathinna, a shelter at Fingal Park, St Marys Cemetery revitalisation and streetscape works in Fingal. Some of these projects had been on the Council's wish list for some time just waiting for funding, the Drought Community Funding has allowed the Council to effectively move up the timeline for many of these projects.

Through the implementation of these projects six full time positions have been created for a period of 20 weeks. Council has also ensured that local contractors and business will receive first priority as contractors or service providers during the term of the project.

"Not only are we creating short term employment and the opportunity for skill development, we are able to provide much needed infrastructure to the community that they have been asking for." Mayor Mick Tucker said.

"Best of all, we have selected projects that will provide visitors with more reasons to stop and enjoy the beautiful Fingal Valley."

significance it is extremely important to control.

Break O'Day is a Zone A area for Patersons Curse meaning eradication rather than containment and now is the best time for treatment. Small plants can be dug out ensuring the tap root is removed. They can also be carefully spot sprayed with a registered herbicide. When treating any weed, remember the 'outside in' rule, working from the outside of the infestation into the middle.

St Marys Flood Mitigation update

The planned works for the St Marys Flood Mitigation works include reducing flood risks by lifting The Flat Bridge and a levee bank to protect housing behind Story Street upstream of Groom Street, and a flash flood warning system involving a new rain gauge and flood alert communications. Depending on the receipt of funding, works could start in October, but most are planned for early next year.

Earlier this year Council followed up the 2017-18 flood studies project with the St Marys Flood Risk Management Plan 2018-2023. Other priorities in the plan include management of vegetation, particularly below Story Street, and developing flood response plans, triggered by the flash flood warning system. It also recognises that the value of the Rivulet as an natural asset for the town needs to be considered. Flood risks are felt across the community and Council will continue to work with households, business and
