- 2. Tenders must be placed in a sealed envelope, marked confidential and delivered to:

  - ST HELENS TAS 7216
- Items will be available for inspection between the hours of 9am and 3pm, Monday Friday, 17 July – 28 July 2023.
- 4. Items are offered for sale "As is, where is" with all faults (if any).
- 5. No warranty is offered on any items.
- 6. Break O'Day Council will not be liable for any loss, damage costs or expense suffered or incurred by a purchaser arising out of purchase of an item.
- 7. Successful tenderers will be notified within 10 business days after close of tender. Unsuccessful tenderers will not be contacted.
- 8. Full payment must be received by EFT, Bank Cheque or Cash within 5 working days of notification of successful purchase. (Personal cheques will not be accepted).
- 9. Items will be available for pickup on receipt of full payment and must be removed from the premises by Thursday 31 August 2023 unless prior arrangements have been made with the Works Department.
