Break O'Day

Isn't it great to see the first few days of Summer appear right at the start of December. Lovely sunny days and reasonable temperatures overnight are what we enjoy and certainly improve how we feel. After a period of regular rain we can only hope that things are on the improve and we are heading for a good summer. Though not wanting to dampen your happiness the Bureau of Meteorology provide a dark cloud on the horizon reporting that we are heading for a wetter than normal summer through into late January.

The weather we are having is causing challenges with grass growth. As quick as we cut them they need doing again, just like you with your lawns. This means we have had to divert some of our team members away from construction activities to help our hardworking and overwhelmed maintenance crews. Walking up the street I can't help but be proud of the way the garden bed on the corner of Cecilia and Quail Streets now look. This splash of colour in the centre of town replaces an area which for a long time looked a bit unloved.

Vacant blocks are guite often the bane of people's lives, whether you are a neighbour or just someone who passes by. This year we cant help but notice the really long grass and just wish the owner would do something about it. Just like you, Council officers see these blocks and are frustrated that we can't do something about it. Unfortunately our powers are quite limited in this space until it meets the definition of a fire hazard and then we can take action. Until we get to that stage, all we can do is send the person a letter, which we have done in the last week, and appeal to their responsible property owner nature. Unfortunately some just don't seem to care and often ignore the letter. Fingers crossed for better weather than predicted and that people to do the right thing and remove potential fire hazards from their properties.



Fairy Terns return to raise their families

Just like many humans, the Fairy Terns have decided to raise their families on beaches in our area.

The Fairy Tern is a vulnerable shore bird species found in Tasmania, Victoria, Western Australia and South Australia where it is listed as endangered.

It is estimated that approximately 30 -50% of the entire Fairy Tern population is currently nesting on our shores. Some of the breeding pairs have even been spotted with eggs and young. So that we can give these birds and their chicks the best chance of survival it is important that we stay away from them.

The Parks and Wildlife team have fenced off some of these nesting sites to keep them protected so if you come across any of these sites please stay away.

Aside from keeping your distance from nesting birds, you can also stay on the wet sand when walking on the beach, and if walking your dog, stick to the dog zones.

In Break O'Day we have established Dog zones which tell you where you can take your dog on and off leash in our area. You can find a link to the Dog Management

Fire Hazards and maintaining your property

As we head towards the fire season it is more important than ever, and your responsibility, to make sure your property is maintained. This means making sure the grass is mown and overgrown vegetation removed.

Because the grass is still green we are unable to issue abatements for overgrown properties but it is in your best interest to maintain now and not wait to the very last minute. Every year after we issue abatements, property owners rush to get their blocks under control. Due to the lack of slashers and like service providers in our area this means people have long wait times and often cannot get them slashed within the allotted timeframe. You don't let your lawn get too overgrown, the same should apply to your block!

Snakes are out and about - Look out

It is that time of year when we start seeing more snakes around the area and we start receiving calls from concerned community members. However, there is very little Council can do other than direct you to Reptile Rescue – www.reptilerescue.org.au.

The simple truth is that when you live in an area like ours, snakes are a part of life. If you see one while out and about on one of the many walking or cycling tracks, the best thing to do is keep your distance.

If you spot one on your property that

is hanging around and causing you distress, get in touch with Reptile Rescue.

Other things you can do to keep yourself and your pet safe:

- Keep your dog on-lead while on bush/beach tracks
- If you spot a snake stand still and keep calm until it leaves
- Get rid of any potential snake hiding places around your home
- Get rid of any potential food sources around your home – mice, frogs, rats etc



November Council Meeting decisions

 - Further upgrades to the Tasman Highway from Dianas Basin to the bottom of St Marys Pass
 - Housing Needs Assessment – advocate the Tasmanian Government to complete a housing assessment of the BOD area

Illegal Tree Removal On Sunday 21 November, a gum tree

On Sunday 21 November, a gum tree was illegally removed from Council leased land/ road reserve on St Helens Point Road.

Not only was this irresponsible act illegal, the individual/s responsible put their own lives and those of the community at risk by felling the tree in a public place right next to a public road without any professional advice or assistance.

Council, the Tasmanian Parks and Wildlife Service as well as Tasmania Police are now involved and the matter is currently under investigation and may lead to prosecution.

The Annual Report is now available





Council Works Reports

The Council works crew have been working hard to keep on top of grass mowing around the municipality as well as wrapping up projects in time for the Christmas Holidays. This includes:

- Falmouth Road Sealing: Resheeting of Morrison and Franks Streets are underway with sealing scheduled for completion before Christmas subject to weather
- Binalong Bay Foreshore footpath: Major works scheduled to be completed prior to Christmas, with minor finishing works to occur during January.
- Slashing: Our slashing contractor has started in Weldborough and will be working their way south through Pyengana and St Helens.
- **Beauty Bay Jetty:** Works to replace the jetty are well underway and on schedule for completion by Christmas.
- General Road maintenance: We have been addressing potholes and road pavement failures at St Helens Point and Gardens Roads. Reconstruction in progress at Medea Cove Esplanade.
- Scamander Playground Fence installation: A contractor will be installing fencing around the Scamander Playground starting December 6.
- Wrinklers Toilet Block and Carpark: Construction of the Carpark at Wrinklers is scheduled to start early December. The toilet block works have been postponed while we wait for materials to arrive.
- Lions Park BBQ area: Works refurbishing the Lions Park BBQ are now complete. These works were made possible by the Lions Club who donated \$12,000 to the project. (Pictured)



Weed of the month - Gorse



Gorse is one of the worst weeds in Australia and Tasmania. While Break O'Day has some badly infested areas, much of the municipality is gorse free or nearly so. Many landholders have embarked on control programs.

Gorse seeds remain viable in the soil

for up to 30 years so plan carefully and don't waste time and resources. Prevent seed production, start on isolated plants and patches; dig out smaller plants. Herbicides used safely and following the label are effective tools (cut-&-paint or spray). Gorse has some helpful biological control pests, and slashing, grazing, heaping and maybe fire can be useful methods to consider, but not without follow-up.

Make a long-term control plan with a range of control methods. Diligent annual follow-up is critical. And practice good hygiene to prevent gorse form spreading, EG. refuse dirty earthmoving machinery that might be carrying a 30 year headache.

Community Grants NOW OPEN

This funding program provides grants to communities to improve facilities/ programs in their township or to improve the overall amenity of their town. All community groups that represent the ratepayers of their community are eligible to apply for funding.

Projects that will be considered for funding but not necessarily restricted to:

- Beautification projects
- Projects to improve or construct recreation facilities
- Projects that will improve the amenity of the township/ community

Projects that will not be considered:

 Any projects on privately owned land or which cannot be freely

- accessed by all community members
- Capital Works projects (ie. Footpaths, kerb and guttering etc.)
