Arts & Culture Community Grant Program

2025 - 2026

Guidelines:

The Arts & Culture Community Grant provides funding to community groups and organisations based in the Break O'Day municipality to support arts, culture, and creative projects that foster inclusion, participation, and local identity.

The program encourages projects that build community wellbeing, celebrate diversity, and contribute to a vibrant local arts and culture scene.

Priority will be given to projects that:

- Create ongoing cultural or artistic benefits for the community.
- Encourage collaboration between artists, community members and cultural groups.
- Reflect the unique character, stories or heritage of the Break O'Day area.
- Promote inclusiveness, accessibility and participation in the arts.
- Provide opportunities for skill development or creative expression.

Activities that will be considered for funding but not necessarily restricted to:

- Public art and creative placemaking projects
- Community arts workshops or exhibitions
- Cultural festivals or performances
- Projects celebrating Aboriginal and Torres Strait Islander culture
- Heritage story telling or digital art initiatives
- Collaborative creative projects involving diverse groups

Activities that will not be considered:

- Projects on privately owned land or inaccessible to the public.
- Capital works (eg., footpaths, infrastructure upgrades).
- Ongoing operational or administrative costs (eg, staff, insurance).
- Projects by commercial businesses or registered schools.
- Projects that have not acquitted Council grants.

Eligibility

- Open to not-for-profit community groups, arts collectives, and incorporated cultural organisations based in Break O'Day.
- Applicants must demonstrate the capacity to deliver the project and manage funds responsibly.
- Groups who have not acquitted prior Council grants are ineligible.
- Non-incorporated groups require an auspicings organisation.

1. Description of the project/activity – provide a clear and detailed plan including timeline and outcomes.

2. Benefit to the community – Explain how the project will strengthen arts and culture in the region.

3. Sustainable outcomes – Describe how the project’s impact will continue beyond the funding period.

4. Support for the project – include evidence of community and partner support, both financial and in-kind for the project.

5. Financial and project management – provide a clear budget and demonstrate the organisation’s ability to manage funds.
